


# Summary Outputs from the 1<sup>st</sup> round of Lyminge Parish engagement on a Neighbourhood Plan



A Neighbourhood Plan puts in place planning policy for a neighbourhood area to guide future development. It is about the use and development of land and allows local community representatives to have a say in proposed future developments. It also deals with a wide range of social, economic and environmental issues (such as housing, employment, design, heritage and transport) and will be used by us, your parish council, to help us make the best decisions for the community.






## The Plan will cover all of Lyminge Parish

# There is a three stage process – this was the engagement for stage 1





18 months to 2 years

We completed six 2 hour sessions across the three villages in the Parish. These events were based on a 'market place' approach where information was presented alongside spaces for residents to provide their thoughts and opinions. They were facilitated by members of Lyminge Parish Council (8 of 12 councillors attended)

The events were on the following days:

- Lyminge 27<sup>th</sup> September & 8<sup>th</sup> October
- Etchinghill 24<sup>th</sup> September & 5<sup>th</sup> October
- Rhodes Minnis 30<sup>th</sup> September & 1<sup>st</sup> October

We asked residents who attended their opinions based on 5 questions:

- 1. What is Good about Lyminge Parish
- 2. What is bad about Lyminge Parish
- 3. What are the Qualities of this as a place to live in
- 4. What are the Issues of this as a place to live in
- 5. What changes would you like to see












#### Who attended



- Excluding councillors 61 members of the public attended the event, this included 57 adults and 4 children. All contributed towards the outputs of the event.
- More women than men attended the events (although we did not ask those who attended what gender they identify as).
- Etchinghill was the village with most attendees
- 403 individual pieces of feedback were captured and will be summarised in this document
- Where it was possible to discern 57% of feedback was positive about the village
- 72 ideas for improvement were identified for the Neighbourhood plan and parish council to address








#### What is Good and Bad about the village




#### What are the Qualities and Issues

For this workstation members of the public were asked to capture on sticky notes what the qualities and issues of the area are



Issues for Lyminge Parish seem to focus around:

- Road quality and speeding through the villages
- Bus services expense, frequency and connectivity t o commuting train lines
- Sewage capacity especially in light of development planned in and around Etchinghill
- Cycle safety





#### **Proposed changes**



For this workstation members of the public were asked to capture on sticky notes what changes they would like to see in the neighbourhood plan. There were 79 proposed changes. That could be broken down into 7 themes that could be use to structure the Neighbourhood Plan.



The changes can be shared with local leads.


