- To instruct a suitable person to clear and mow a path around the bird cherry tree on Tayne Field, close to the back entrance to the garden of the Coach and Horses pub.
- To approve the removal of brambles encroaching on the central areas of Court Lodge Green by volunteers from Lyminge Climate Action.
